## A Theoretical Derivations and Proofs

## A. 1 Proofs for Section 3.2

## A.1.1 Preliminaries

Throughout the proofs, we use the notation $\epsilon$ for a small positive constant such that

$$
0<\epsilon<\epsilon_{0} .
$$

In addition, we will make use of the following two lemmas.

Lemma A. 1 If $A_{N}(\pi)=o_{u . \pi}\left(N^{+}\right)$and $B_{N}(\pi)=o_{u . \pi}\left(N^{+}\right)$, then $C_{N}(\pi)=A_{N}(\pi)+B_{N}(\pi)=$ $o_{u . \pi}\left(N^{+}\right)$.

Proof of Lemma A.1. Take an arbitrary $\epsilon>0$. We need to show that there exists a sequence $\eta_{N}^{c}(\epsilon)$ such that

N^{-\epsilon} C_{N}(\pi) \leq \eta_{N}^{c}(\epsilon)
$$

Write

$$
N^{-\epsilon} C_{N}(\pi)=N^{-\epsilon}\left(A_{N}(\pi)+B_{N}(\pi)\right)
$$

Because $A_{N}$ and $B_{N}$ are subpolynomial, there exist sequences $\eta_{N}^{a}(\epsilon)$ and $\eta_{N}^{b}(\epsilon)$ such that

$$
N^{-\epsilon}\left(A_{N}(\pi)+B_{N}(\pi)\right) \leq \eta_{N}^{a}(\epsilon)+\eta_{N}^{b}(\epsilon) .
$$

Thus, we can choose $\eta_{N}^{c}(\epsilon)=\eta_{N}^{a}(\epsilon)+\eta_{N}^{b}(\epsilon) \longrightarrow 0$ to establish the claim.

Lemma A. 2 If $A_{N}(\pi)=o_{u . \pi}\left(N^{+}\right)$and $B_{N}(\pi)=o_{u . \pi}\left(N^{+}\right)$, then $C_{N}(\pi)=A_{N}(\pi) B_{N}(\pi)=$ $o_{u . \pi}\left(N^{+}\right)$.

Proof of Lemma A.2. Take an arbitrary $\epsilon>0$. We need to show that there exists a sequence $\eta_{N}^{c}(\epsilon)$ such that

N^{-\epsilon} C_{N}(\pi) \leq \eta_{N}^{c}(\epsilon)
$$

Write

$$
N^{-\epsilon} C_{N}(\pi)=\left(N^{-\epsilon / 2} A_{N}(\pi)\right)\left(N^{-\epsilon / 2} B_{N}(\pi)\right)
$$

Because $A_{N}$ and $B_{N}$ are subpolynomial, there exist sequences $\eta_{N}^{a}(\epsilon / 2)$ and $\eta_{N}^{b}(\epsilon / 2)$ such that

$$
\left(N^{-\epsilon / 2} A_{N}(\pi)\right)\left(N^{-\epsilon / 2} B_{N}(\pi)\right) \leq \eta_{N}^{a}(\epsilon / 2) \eta_{N}^{b}(\epsilon / 2)
$$

Thus, we can choose $\eta_{N}^{c}(\epsilon)=\eta_{N}^{a}(\epsilon / 2) \eta_{N}^{b}(\epsilon / 2) \longrightarrow 0$ to establish the claim.

## A.1.2 Main Theorem

Proof of Theorem 3.7. The goal is to prove that for any given $\epsilon_{0}>0$

\limsup _{N \rightarrow \infty} \sup _{\pi \in \Pi} \frac{R_{N}\left(\widehat{Y}_{T+1}^{N} ; \pi\right)-R_{N}^{\mathrm{opt}}(\pi)}{N \mathbb{E}_{\theta ; \pi}^{\mathcal{Y}_{i}^{i}, \lambda_{i}}\left[\left(\lambda_{i}-\mathbb{E}_{\theta, \pi, \mathcal{y}^{i}}^{\lambda_{i}}\left[\lambda_{i}\right]\right)^{2}\right]+N^{\epsilon_{0}}} \leq 0 \tag{A.1}
\end{equation*}
$$

where

$$
\begin{aligned}
R_{N}\left(\widehat{Y}_{T+1}^{N} ; \pi\right) & =N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}, \lambda_{i}}\left[\left(\lambda_{i}+\rho Y_{i T}-\widehat{Y}_{i T+1}\right)^{2}\right]+N \sigma^{2} \\
R_{N}^{\mathrm{opt}}(\pi) & =N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}_{i}, \lambda_{i}}\left[\left(\lambda_{i}-\mathbb{E}_{\theta, \pi, \mathcal{Y}_{i}}^{\lambda_{i}}\left[\lambda_{i}\right]\right)^{2}\right]+N \sigma^{2}
\end{aligned}
$$

Here we used the fact that there is cross-sectional independence and symmetry in terms of $i$. The statement is equivalent to

\begin{equation*}
\limsup _{N \rightarrow \infty} \sup _{\pi \in \Pi} \frac{N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}, \lambda_{i}}\left[\left(\lambda_{i}+\rho Y_{i T}-\widehat{Y}_{i T+1}\right)^{2}\right]}{N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{i}, \lambda_{i}}\left[\left(\lambda_{i}-\mathbb{E}_{\theta, \pi, \mathcal{Y}^{i}}^{\lambda_{i}}\left[\lambda_{i}\right]\right)^{2}\right]+N^{\epsilon_{0}}} \leq 1 \tag{A.2}
\end{equation*}
$$

Here we made the dependence on $\pi$ of the risks and the posterior moments explicit. In the calculations below, we often drop the $\pi$ argument to simplify the notation.

In the main text we asserted that

$$
\begin{equation*}
p_{*}\left(\hat{\lambda}_{i}, y_{i 0}\right)=\mathbb{E}_{\theta, \pi, \mathcal{y}_{i}}^{\mathcal{Y}(-i)}\left[\hat{p}^{(-i)}\left(\hat{\lambda}_{i}, y_{i 0}\right)\right] . \tag{A.3}
\end{equation*}
$$

This assertion can be verified as follows. Taking expectations with respect to ( $\hat{\lambda}_{j}, y_{j, 0}$ ) for $j \neq i$ yields

& =\sum_{j \neq i} \iint \frac{1}{B_{N}} \phi\left(\frac{\hat{\lambda}_{i}-\hat{\lambda}_{j}}{B_{N}}\right) \frac{1}{B_{N}} \phi\left(\frac{y_{i 0}-y_{j 0}}{B_{N}}\right) p\left(\hat{\lambda}_{j}, y_{j 0}\right) d \hat{\lambda}_{j} d y_{j 0} \\
& =\iint \frac{1}{B_{N}} \phi\left(\frac{\hat{\lambda}_{i}-\hat{\lambda}_{j}}{B_{N}}\right) \frac{1}{B_{N}} \phi\left(\frac{y_{i 0}-y_{j 0}}{B_{N}}\right) p\left(\hat{\lambda}_{j}, y_{j 0}\right) d \hat{\lambda}_{j} d y_{j 0} .
\end{aligned}
$$

The second equality follows from the symmetry with respect to $j$ and the fact that we integrate out $\left(\hat{\lambda}_{j}, y_{j 0}\right)$. We now substitute in

p\left(\hat{\lambda}_{j}, y_{j 0}\right)=\int p\left(\hat{\lambda}_{j} \mid \lambda_{j}\right) \pi\left(\lambda_{j}, y_{j 0}\right) d \lambda_{j}
$$

where

p\left(\hat{\lambda}_{j} \mid \lambda_{j}\right)=\frac{1}{\sigma / T} \phi\left(\frac{\hat{\lambda}_{j}-\lambda_{j}}{\sigma / T}\right)
$$

and change the order of integration. This leads to:

& \mathbb{E}_{\theta, \pi, y_{i}}^{\mathcal{Y}(-i)}\left[\hat{p}^{(-i)}\left(\hat{\lambda}_{i}, y_{i 0}\right)\right] \\
& \quad=\iint\left[\int \frac{1}{B_{N}} \phi\left(\frac{\hat{\lambda}_{i}-\hat{\lambda}_{j}}{B_{N}}\right) p\left(\hat{\lambda}_{j} \mid \lambda_{j}\right) d \hat{\lambda}_{j}\right] \frac{1}{B_{N}} \phi\left(\frac{y_{i 0}-y_{j 0}}{B_{N}}\right) \pi\left(\lambda_{j}, y_{j 0}\right) d \lambda_{j} d y_{j 0} \\
& \quad=\iint \frac{1}{\sqrt{\sigma^{2} / T+B_{N}^{2}}} \phi\left(\frac{\hat{\lambda}_{i}-\lambda_{j}}{\sqrt{\sigma^{2} / T+B_{N}^{2}}}\right) \frac{1}{B_{N}} \phi\left(\frac{y_{i 0}-y_{j 0}}{B_{N}}\right) \pi\left(\lambda_{j}, y_{j 0}\right) d \lambda_{j} d y_{j 0} \\
& \quad=\int \frac{1}{\sqrt{\sigma^{2} / T+B_{N}^{2}}} \phi\left(\frac{\hat{\lambda}_{i}-\lambda_{j}}{\sqrt{\sigma^{2} / T+B_{N}^{2}}}\right)\left[\int \frac{1}{B_{N}} \phi\left(\frac{y_{i 0}-y_{j 0}}{B_{N}}\right) \pi\left(y_{j 0} \mid \lambda_{j}\right) d y_{j 0}\right] \pi\left(\lambda_{j}\right) d \lambda_{j} .
\end{aligned}
$$

Now re-label $\lambda_{j}$ and $\lambda_{i}$ and $y_{j 0}$ as $\tilde{y}_{i 0}$ to obtain:

& \quad=\int \frac{1}{\sqrt{\sigma^{2} / T+B_{N}^{2}}} \phi\left(\frac{\hat{\lambda}_{i}-\lambda_{i}}{\sqrt{\sigma^{2} / T+B_{N}^{2}}}\right)\left[\int \frac{1}{B_{N}} \phi\left(\frac{y_{i 0}-\tilde{y}_{i 0}}{B_{N}}\right) \pi\left(\tilde{y}_{i 0} \mid \lambda_{i}\right) d \tilde{y}_{i 0}\right] \pi\left(\lambda_{i}\right) d \lambda_{i} .
\end{aligned}
$$

Risk Decomposition. We begin by decomposing the forecast error. Let

\begin{equation*}
\mu\left(\lambda, \omega^{2}, p\left(\lambda, y_{0}\right)\right)=\lambda+\omega^{2} \frac{\partial \ln p\left(\lambda, y_{0}\right)}{\partial \lambda} . \tag{A.4}
\end{equation*}
$$

Using the previously developed notation, we expand the prediction error due to parameter estimation as follows:

\widehat{Y}_{i T+1} & -\lambda_{i}-\rho Y_{i T} \\
= & {\left[\mu\left(\hat{\lambda}_{i}(\hat{\rho}), \hat{\sigma}^{2} / T+B_{N}^{2}, \hat{p}^{(-i)}\left(\hat{\lambda}_{i}(\hat{\rho}), Y_{i 0}\right)\right)\right]^{C_{N}}-m_{*}\left(\hat{\lambda}_{i}, y_{i 0} ; \pi, B_{N}\right) } \\
& +m_{*}\left(\hat{\lambda}_{i}, y_{i 0} ; \pi, B_{N}\right)-\lambda_{i} \\
& +(\hat{\rho}-\rho) Y_{i T} \\
= & A_{1 i}+A_{2 i}+A_{3 i}, \text { say. }
\end{aligned}
$$

Now write

$$
N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}}\left[\left(\lambda_{i}+\rho Y_{i T}-\widehat{Y}_{i T+1}\right)^{2}\right]=N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}}\left[\left(A_{1 i}+A_{2 i}+A_{3 i}\right)^{2}\right] .
$$

We deduce from the $C_{r}$ inequality that the statement of the theorem follows if we can show that
(i) $N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}}\left[A_{1 i}^{2}\right]=o_{u . \pi}\left(N^{\epsilon_{0}}\right)$,
(ii) $\limsup _{N \rightarrow \infty} \sup _{\pi \in \Pi} \frac{N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}, \lambda_{i}}\left[A_{2 i}^{2}\right]}{N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{i}, \lambda_{i}}\left[\left(\lambda_{i}-\mathbb{E}_{\theta, \pi, \mathcal{Y}^{i}}^{\lambda_{i}}\left[\lambda_{i}\right]\right)^{2}\right]+N^{\epsilon_{0}}} \leq 1$,
(iii) $\quad N \mathbb{E}_{\theta, \pi}^{\mathcal{Y}^{N}}\left[A_{3 i}^{2}\right]=o_{u . \pi}\left(N^{+}\right)$.

The required bounds are provided in Lemmas A. 3 (term $A_{1 i}$ ), A. 4 (term $A_{2 i}$ ), A. 5 (term $A_{3 i}$ ).

## A.1.3 Three Important Lemmas

Truncations. The remainder of the proof involves a number of truncations that we will apply when analyzing the risk terms. We take the sequence $C_{N}$ as given from Assumption 3.3. Recall that

We introduce a new sequence diverging sequence $L_{N}$ with the properties

\end{equation*}

Even though we do not indicate this explicitly through our notation, we also restrict the domain of $\left(\lambda, y_{0}\right)$ arguments that appear in numerous expressions throughout the proof
to the support of the distribution of the random variables $\left(\lambda_{i}, Y_{i 0}\right)$, which is defined as $\operatorname{Supp}_{\lambda, Y_{0}}=\left\{\left(\lambda, y_{0}\right) \in \mathbb{R}^{2} \mid \pi\left(\lambda, y_{0}\right)>0\right\}$.

1. Define the truncated region $\mathcal{T}_{\lambda}=\left\{|\lambda| \leq C_{N}\right\}$. From Assumption 3.2 we obtain for $C_{N} \geq M_{3}$ that

N^{1-\epsilon} \mathbb{P}\left(\mathcal{T}_{\lambda}^{c}\right) & \leq M_{1} \exp \left((1-\epsilon) \ln N-M_{2}\left(C_{N}-M_{3}\right)\right)  \tag{A.6}\\
& =\widetilde{M}_{1} \exp \left(-M_{2}\left[C_{N}-\frac{1-\epsilon}{M_{2}} \ln N\right]\right) \\
& =o(1)
\end{align*}
$$

for all $0<\epsilon$ because, according to Assumption 3.3, $C_{N}>2(\ln N) / M_{2}$. Thus, we can deduce

N \mathbb{P}\left(\mathcal{T}_{\lambda}^{c}\right)=o_{u . \pi}\left(N^{+}\right)
$$

2. Define the truncated region $\mathcal{T}_{Y_{0}}=\left\{\max _{1 \leq i \leq N}\left|Y_{i 0}\right| \leq L_{N}\right\}$. Then,

\begin{align*}
N^{1-\epsilon} \mathbb{P}\left(\mathcal{T}_{Y_{0}}^{c}\right) & =N^{1-\epsilon} \mathbb{P}\left\{\max _{1 \leq i \leq N}\left|Y_{i 0}\right| \geq L_{N}\right\}  \tag{A.7}\\
& \leq N^{1-\epsilon} \sum_{i=1}^{N} \mathbb{P}\left\{\left|Y_{i 0}\right| \geq L_{N}\right\} \\
& =N^{2-\epsilon} \int_{\left|y_{0}\right| \geq L_{N}} \pi\left(y_{0}\right) d y_{0} \\
& \leq \widetilde{M}_{1} \exp \left(-M_{2}\left[L_{N}-\frac{2-\epsilon}{M_{2}} \ln N\right]\right) \\
& =o(1),
\end{align*}
$$

for all $\epsilon>0$ because according to (A.5) $L_{N}>\left(2 / M_{2}\right) \ln N$. Thus, we deduce that

N \mathbb{P}\left(\mathcal{T}_{Y_{0}}^{c}\right)=o_{u . \pi}\left(N^{+}\right)
$$

3. Define the truncated region $\mathcal{T}_{\hat{\rho}}=\left\{|\hat{\rho}-\rho| \leq 1 / L_{N}^{2}\right\}$. By Chebyshev's inequality, Assumption 3.6, and (A.5), we can bound

$$
\begin{equation*}
N \mathbb{P}\left(\mathcal{T}_{\hat{\rho}}^{c}\right)=N \mathbb{P}\left\{|\hat{\rho}-\rho|>1 / L_{N}^{2}\right\} \leq L_{N}^{4} \mathbb{E}\left[N(\hat{\rho}-\rho)^{2}\right]=o_{u . \pi}\left(N^{+}\right) \tag{A.8}
\end{equation*}
$$

4. Define the truncated region $\mathcal{T}_{\hat{\sigma}^{2}}=\left\{\left|\hat{\sigma}^{2}-\sigma^{2}\right| \leq 1 / L_{N}\right\}$. By Chebyshev's inequality,

Assumption 3.6, and (A.5), we can bound

$$
\begin{equation*}
N \mathbb{P}\left(\mathcal{T}_{\hat{\sigma}^{2}}^{c}\right)=N \mathbb{P}\left\{\left|\hat{\sigma}^{2}-\sigma^{2}\right|>1 / L_{N}\right\} \leq L_{N}^{2} \mathbb{E}\left[N\left(\hat{\sigma}^{2}-\sigma^{2}\right)^{2}\right]=o_{u . \pi}\left(N^{+}\right) \tag{A.9}
\end{equation*}
$$

5. Let $\bar{U}_{i,-1}(\rho)=\frac{1}{T} \sum_{t=2}^{T} U_{i t-1}(\rho)$ and $U_{i t}(\rho)=U_{i t}+\rho U_{i t-1}+\cdots+\rho^{t-1} U_{i 1}$. Define the truncated region $\mathcal{T}_{\bar{U}}=\left\{\max _{1 \leq i \leq N}\left|\bar{U}_{i,-1}(\rho)\right| \leq L_{N}\right\}$. Notice that $\bar{U}_{i,-1}(\rho) \sim \operatorname{iidN}\left(0, \sigma_{\bar{U}}^{2}\right)$ with $0<\sigma_{\bar{U}}^{2}<\infty$. Thus, we have

$$
\begin{align*}
N \mathbb{P}\left(\mathcal{T}_{\bar{U}}^{c}\right) & =N \mathbb{P}\left\{\max _{1 \leq i \leq N}\left|\bar{U}_{i,-1}(\rho)\right| \geq L_{N}\right\}  \tag{A.10}\\
& \leq N \sum_{i=1}^{N} \mathbb{P}\left\{\left|\bar{U}_{i,-1}(\rho)\right| \geq L_{N}\right\}=N^{2} \mathbb{P}\left\{\left|\bar{U}_{i,-1}(\rho)\right| \geq L_{N}\right\} \\
& \leq 2 N^{2} \exp \left(-\frac{L_{N}^{2}}{2 \sigma_{\bar{U}}^{2}}\right)=2 \exp \left(-\frac{L_{N}^{2}}{2 \sigma_{\bar{U}}^{2}}+2 \ln N\right) \\
& \leq 2 \exp \left(-2\left(\frac{\ln N}{M_{2}^{2} \sigma_{\bar{U}}^{2}}-1\right) \ln N\right) \\
& =o_{u \cdot \pi}\left(N^{+}\right)
\end{align*}
$$

where the last inequality holds by (A.5).
6. Let $\bar{Y}_{i,-1}=C_{1}(\rho) Y_{i 0}+C_{2}(\rho) \lambda_{i}+\bar{U}_{i,-1}(\rho)$, where $C_{1}(\rho)=\frac{1}{T} \sum_{t=1}^{T} \rho^{t-1}, C_{2}(\rho)=$ $\frac{1}{T} \sum_{t=2}^{T}\left(1+\cdots+\rho^{t-2}\right)$. Because $T$ is finite and $|\rho|$ is bounded, there exists a finite constant, say $M$ such that $\left|C_{1}(\rho)\right| \leq M$ and $\left|C_{2}(\rho)\right| \leq M$. Then, in the region $\mathcal{T}_{\lambda} \cap \mathcal{T}_{Y_{0}} \cap \mathcal{T}_{\bar{U}}:$

\max _{1 \leq i \leq N}\left|\bar{Y}_{i,-1}\right| & \leq\left|C_{1}(\rho)\right| \max _{1 \leq i \leq N}\left|\lambda_{i}\right|+\left|C_{2}(\rho)\right| \max _{1 \leq i \leq N}\left|Y_{i 0}\right|+\max _{1 \leq i \leq N}\left|\bar{U}_{i,-1}(\rho)\right| \\
& \leq M\left(C_{N}+L_{N}+L_{N}\right)
\end{aligned}
$$

which leads to

$$
\begin{equation*}
\max _{1 \leq i, j \leq N}\left|\bar{Y}_{j,-1}-\bar{Y}_{i,-1}\right| \leq 2 \max _{1 \leq i \leq N}\left|\bar{Y}_{i,-1}\right| \leq 2 M\left(C_{N}+2 L_{N}\right)=o_{u . \pi}\left(N^{+}\right) . \tag{A.11}
\end{equation*}
$$

7. For the region $\mathcal{T}_{\lambda} \cap \mathcal{T}_{Y_{0}} \cap \mathcal{T}_{\hat{\rho}} \cap \mathcal{T}_{\bar{U}}$ and with some finite constant $M$, we obtain the bound

\max _{1 \leq i, j \leq N}\left|(\hat{\rho}-\rho)\left(\bar{Y}_{j,-1}-\bar{Y}_{i,-1}\right)\right| \leq \frac{M\left(C_{N}+L_{N}\right)}{L_{N}^{2}}=o_{u . \pi}\left(N^{+}\right) \tag{A.12}
\end{equation*}
$$

8. Define the regions $\mathcal{T}_{m}=\left\{\left|m\left(\hat{\lambda}_{i}, Y_{i 0}\right)\right| \leq C_{N}\right\}$ and $\mathcal{T}_{m *}=\left\{\left|m_{*}\left(\hat{\lambda}_{i}, Y_{i 0}\right)\right| \leq C_{N}\right\}$. By Chebyshev's inequality and Assumption 3.5, we deduce

$$
\begin{align*}
N \mathbb{P}\left(\mathcal{T}_{m}^{c}\right) & \leq \frac{1}{C_{N}^{2}} N \mathbb{E}\left(m\left(\hat{\lambda}_{i}, Y_{i 0}\right)^{2} \mathcal{T}_{m}^{c}\right) \leq o_{u . \pi}\left(N^{+}\right)  \tag{A.13}\\
N \mathbb{P}\left(\mathcal{T}_{m_{*}}^{c}\right) & \leq \frac{1}{C_{N}^{2}} N \mathbb{E}\left(m_{*}\left(\hat{\lambda}_{i}, Y_{i 0}\right)^{2} \mathcal{T}_{m_{*}}^{c}\right) \leq o_{u . \pi}\left(N^{+}\right)
\end{align*}
$$

Y_{i T}=\rho^{T} Y_{i 0}+\sum_{\tau=0}^{T-1} \rho^{\tau}\left(\lambda_{i}+U_{i T-\tau}\right)

Using the $C_{r}$ inequality and noting that $T$ is finite and $U_{i t} \sim \operatorname{iid} N\left(0, \sigma^{2}\right)$, we deduce that there is a finite constant $M$ that does not depend on $\pi \in \Pi$ such that

The last line holds according to Assumption 3.2 and because $U_{i 1}$ is normally distributed and therefore all its moments are finite.

Notice that conditional on $\left(\hat{\lambda}_{i}, Y_{i 0}\right), \psi_{i}\left(\lambda_{j}, Y_{j 0}\right) \sim$ iid across $j \neq i$ with $\left|\psi_{i}\left(\hat{\lambda}_{j}, Y_{j 0}\right)\right| \leq M$ for some finite constant $M$. Then, by Bernstein's inequality ${ }^{15}$ (e.g., Lemma 19.32 in van der Vaart (1998)),

\begin{aligned}
& N \mathbb{P}_{i}\left\{\hat{p}_{i}^{(-i)}-p_{* i}<-\frac{p_{* i}}{4}\right\} \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right) \\
& \quad=N \mathbb{P}_{i}\left\{\frac{1}{B_{N}^{2}(N-1)} \sum_{j \neq i}^{N}\left(\psi_{i}\left(\hat{\lambda}_{j}, Y_{j 0}\right)-\mathbb{E}_{i}\left[\psi_{i}\left(\hat{\lambda}_{j}, Y_{j 0}\right)\right]\right)<-\frac{p_{* i}}{4}\right\} \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right) \\
& \leq 2 N \exp \left(-\frac{1}{4} \frac{B_{N}^{4}(N-1) p_{* i}^{2} / 16}{\mathbb{E}_{i}\left[\psi_{i}\left(\hat{\lambda}_{j}, Y_{j 0}\right)^{2}\right]+M B_{N}^{2} p_{i *} / 4}\right) \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right)
\end{aligned}
$$

[^0]Using an argument similar to the proof of Lemma A. 6 one can show that

N \mathbb{P}_{i}\left\{\hat{p}_{i}^{(-i)}-p_{* i}<-\frac{p_{* i}}{4}\right\} \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right) \leq 2 \exp \left(-M N B_{N}^{2} \frac{p_{* i}^{2}}{p_{i}+p_{* i}}+\ln N\right) \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right) .

From Lemma A. 7 we can find a constant $c$ such that $p_{i} \leq(1+c) p_{* i}$ and $p_{* i} \leq(1+c) p_{i}$. This leads to

& \quad \leq 2 \mathbb{E}\left[\exp \left(-M N B_{N}^{2} \frac{p_{* i}^{2}}{p_{i}+p_{* i}}+\ln N\right) \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right)\right] \\
& \quad \leq 2 \mathbb{E}\left[\exp \left(-M N B_{N}^{2} p_{i}+\ln N\right) \mathbb{I}\left(\mathcal{T}_{\hat{\lambda} Y_{0}} \mathcal{T}_{p(\cdot)}\right)\right] \\
& \quad \leq 2 \exp \left(-M B_{N}^{2} N^{\epsilon}+\ln N\right) \\
& \quad=o(1),
\end{aligned}
$$

where the last line holds by Assumption 3.3 and the $o(1)$ bound in the last line is uniform in $\pi \in \Pi$. Then, we have the required result for Part (f).

## A. 2 Proofs for Section 3.3

## Proof of Theorem 3.8.

Part (i): we verify that our assumptions hold uniformly for the multivariate normal distributions $\pi \in \Pi$.

Assumption 3.2. Because $\lambda$ is normally distributed, the uncentered fourth moment is finite for each $\pi(\lambda) \in \Pi_{\lambda}$ and can be bounded uniformly. Note that

\end{equation*}
$$

for $C>\left|\mu_{\lambda}\right|+1$. By plugging the bounds from (22) into (A.32) one can obtain constants $M_{1}, M_{2}$, and $M_{3}$ such that Assumption 3.2(i) is satisfied. The second part can be verified by noting that $Y_{0} \sim N\left(\mu_{y}, \sigma_{y}^{2}\right)$, where $\mu_{y}=\alpha_{0}+\alpha_{1} \mu_{\lambda}$ and $\sigma_{y}^{2}=\sigma_{y \mid \lambda}^{2}+\alpha_{1}^{2} \sigma_{\lambda}^{2}$.
Assumption 3.4 The boundedness of the conditional density follows from $0<\delta_{\sigma_{y \mid \lambda}^{2}} \leq \sigma_{y \mid \lambda}^{2}$ in (22). To verify Part (ii) define $\mu_{y}(\lambda)=\alpha_{0}+\alpha_{1} \lambda$ and notice that $\tilde{y} \mid \lambda \sim N\left(\mu_{y}(\lambda), \sigma_{y \mid \lambda}^{2}+B_{N}^{2}\right)$. Thus, we can write

$$

where

$$
\mathcal{R}_{1, N}=\sqrt{\frac{\sigma_{y \mid \lambda}^{2}}{\sigma_{y \mid \lambda}^{2}+B_{N}^{2}}} \leq 1, \quad \mathcal{R}_{2, N}=\exp \left\{-\frac{1}{2}\left(y-\mu_{y}(\lambda)\right)^{2}\left(\frac{1}{\sigma_{y \mid \lambda}^{2}+B_{N}^{2}}-\frac{1}{\sigma_{y \mid \lambda}^{2}}\right)\right\} \geq 1
$$

$\mathcal{R}_{1, N}$ can be bounded from below by replacing $\sigma_{y \mid \lambda}^{2}$ with $\delta_{\sigma_{y \mid \lambda}^{2}}$. Because $B_{N} \longrightarrow 0$ as $N \longrightarrow \infty$, $\mathcal{R}_{1, N} \longrightarrow 1$ uniformly. For the term $\mathcal{R}_{2, N}$ notice that

\left(y-\mu_{y}(\lambda)\right)^{2}\left(\frac{1}{\sigma_{y \mid \lambda}^{2}}-\frac{1}{\sigma_{y \mid \lambda}^{2}+B_{N}^{2}}\right) & =\left(y-\alpha_{0}-\alpha_{1} \lambda\right)^{2} \frac{B_{N}^{2}}{\sigma_{y \mid \lambda}^{2}\left(\sigma_{y \mid \lambda}^{2}+B_{N}^{2}\right)} \\
& \leq 3\left(\left(C_{N}^{\prime}\right)^{2}+M_{\alpha_{0}}^{2}+M_{\alpha_{1}}^{2} C_{N}^{2}\right) \frac{B_{N}^{2}}{\left(\delta_{\sigma_{y \mid \lambda}^{2}}^{2}\right)^{2}} \longrightarrow 0
\end{aligned}
$$

as $N \longrightarrow \infty$ because $B_{N} C_{N}=o(1)$ and $B_{N} C_{N}^{\prime}=o(1)$ according to Assumption 3.3. Thus, $\mathcal{R}_{2, N} \longrightarrow 1$ uniformly which delivers the desired result.

Assumption 3.5. The first step is to derive the conditional prior distribution $\pi(\lambda \mid y)$ which is of the form $\lambda \mid y \sim N\left(\mu_{\lambda \mid y}, \sigma_{y \mid \lambda}^{2}\right)$. The prior mean function is of the form $\mu_{\lambda \mid y}=\gamma_{0}+\gamma_{1} y$. If the prior for $\lambda$ is a point mass, i.e., $\sigma_{\lambda}^{2}=0$, then the distribution of $(\lambda \mid y)$ is also a point mass with $\mu_{\lambda \mid y}=\mu_{\lambda}$ and $\sigma_{\lambda \mid y}^{2}=0$. It can be verified that the coefficients $\gamma_{0}, \gamma_{1}$, and the variance $\sigma_{y \mid \lambda}^{2}$ are bounded from above in absolute value.

The prior is combined with the Gaussian likelihood function $\hat{\lambda} \mid \lambda \sim N\left(\lambda, \sigma^{2} / T\right)$, which leads to a posterior mean function that is linear in $\hat{\lambda}$ and $y$ :

m(\hat{\lambda}, y ; \pi)=\left(\frac{1}{\sigma_{y \mid \lambda}^{2}}+\frac{1}{\sigma^{2} / T}\right)^{-1}\left(\frac{1}{\sigma_{y \mid \lambda}^{2}}\left(\gamma_{0}+\gamma_{1} y_{0}\right)+\frac{1}{\sigma^{2} / T} \hat{\lambda}\right)=\bar{\gamma}_{0}+\bar{\gamma}_{1} y_{0}+\bar{\gamma}_{2} \hat{\lambda} . \tag{A.33}
\end{equation*}
$$

The $\bar{\gamma}$ coefficients are also bounded in absolute value for $\pi \in \Pi$.
The sampling distribution of $\left(\hat{\lambda}, y_{0}\right)$ is jointly normal with mean and covariance matrix

$$
\mu_{\hat{\lambda}, y}=\left[\begin{array}{c}
\mu_{\lambda}  \tag{A.34}\\
\alpha_{0}+\alpha_{1} \mu_{\lambda}
\end{array}\right], \quad \Sigma_{\hat{\lambda}, y}=\left[\begin{array}{cc}
\sigma_{\lambda}^{2}+\sigma^{2} / T & \gamma_{1}\left(\sigma_{y \mid \lambda}^{2}+\alpha_{1}^{2} \sigma_{\lambda}^{2}\right) \\
\gamma_{1}\left(\sigma_{y \mid \lambda}^{2}+\alpha_{1}^{2} \sigma_{\lambda}^{2}\right) & \sigma_{y \mid \lambda}^{2}+\alpha_{1}^{2} \sigma_{\lambda}^{2}
\end{array}\right]
$$

It can be verified that the covariance matrix is always positive definite. The variances of $\hat{\lambda}$ and $y_{0}$ are strictly greater than some $\delta>0$ and the two random variables are never perfectly correlated because $\hat{\lambda}=\lambda+\left(\sum_{t=1}^{T} u_{t}\right) / T$. Moreover, the covariance matrix can be bounded from above. By combining (A.33) and (A.34) we can deduce that the posterior mean has a Gaussian sampling distribution and we can use standard moment and tail bounds to establish the validity of the assumption. Calculations under the $p_{*}(\cdot)$ distributions are very similar.

Part (ii): we verify that our assumptions hold uniformly for the finite mixtures of multivariate normal distributions $\pi_{m i x} \in \Pi_{m i x}^{(K)}$.
Assumption 3.2. Consider the marginal density of $\lambda$ given by $\pi_{m i x}(\lambda)=\sum_{k=1}^{K} \omega_{k} \pi_{k}(\lambda)$. Thus, for any non-negative integrable function $h(\cdot)$ we can use the crude bound

$$
\int h(\lambda) \pi_{m i x}(\lambda) d \lambda \leq \sum_{k=1}^{K} \int h(\lambda) \pi_{k}(\lambda) d \lambda

In turn, uniform tail probability and moment bounds for the mixture components translate into uniform bounds for $\pi_{m i x}(\cdot)$.

Assumption 3.4 The key insight is that we can express

\pi_{m i x}(y \mid \lambda)=\frac{\sum_{k=1}^{K} \omega_{k} \pi_{k}(\lambda, y)}{\sum_{k=1}^{K} \omega_{k} \pi_{k}(\lambda)}=\sum_{k=1}^{K}\left(\frac{\omega_{k} \pi_{k}(\lambda)}{\sum_{k=1}^{K} \omega_{k} \pi_{k}(\lambda)}\right) \frac{\pi_{k}(\lambda, y)}{\pi_{k}(\lambda)} \leq \sum_{k=1}^{K} \pi_{k}(y \mid \lambda)
$$

This allows us to directly translate bounds for the mixture components $\pi_{k}(y \mid \lambda) \in \Pi_{y \mid \lambda}$ into results for $\pi_{m i x}(y \mid \lambda)$. Using a similar argument, we can also deduce that

\begin{aligned}
& \sup _{\pi_{m i x} \in \Pi_{m i x}^{(K)}} \sup _{|y| \leq C_{N}^{\prime},|\lambda|<C_{N}}\left|\frac{\int \frac{1}{B_{N}} \phi\left(\frac{\tilde{y}-y}{B_{N}}\right)\left[\pi_{m i x}(\tilde{y} \mid \lambda)-\pi_{m i x}(y \mid \lambda)\right] d \tilde{y}}{\pi_{m i x}(y \mid \lambda)}\right| \\
& \quad \leq \sum_{k=1}^{K} \sup _{\pi_{k} \in \Pi_{k}} \sup _{|y| \leq C_{N}^{\prime},|\lambda|<C_{N}}\left|\frac{\int \frac{1}{B_{N}} \phi\left(\frac{\tilde{y}-y}{B_{N}}\right)\left[\pi_{k}(\tilde{y} \mid \lambda)-\pi_{k}(y \mid \lambda)\right] d \tilde{y}}{\pi_{k}(y \mid \lambda)}\right| \\
& \quad=o(1) .
\end{aligned}
$$

Assumption 3.5. The prior distribution of $\lambda$ given $y$ is a mixture of normals with weights that are a function of $y$ :

$$
\begin{equation*}
\pi_{m i x}(\lambda \mid y)=\sum_{k=1}^{K}\left(\frac{\omega_{k} \pi_{k}(y)}{\sum_{k=1}^{K} \omega_{k} \pi_{k}(y)}\right) \frac{\pi_{k}(\lambda, y)}{\pi_{k}(y)}=\sum_{k=1}^{K} \underline{\omega}_{k}(y) \pi_{k}(\lambda \mid y) \tag{A.35}
\end{equation*}
$$

Because $\hat{\lambda} \mid \lambda \sim N\left(\lambda, \sigma^{2} / T\right)$, the posterior mean function is given by

$$
\begin{align*}
& m\left(\hat{\lambda}, y ; \pi_{m i x}\right)  \tag{A.36}\\
& =\sum_{k=1}^{K}\left(\frac{\underline{\omega}_{k}(y) \int \pi_{k}(\lambda \mid y) \phi_{N}\left(\hat{\lambda} ; \lambda, \sigma^{2} / T\right) d \lambda}{\sum_{k=1}^{K} \underline{\omega}_{k}(y) \int \pi_{k}(\lambda \mid y) \phi_{N}\left(\hat{\lambda} ; \lambda, \sigma^{2} / T\right) d \lambda}\right) \frac{\int \lambda \pi_{k}(\lambda \mid y) \phi_{N}\left(\hat{\lambda} ; \lambda, \sigma^{2} / T\right) d \lambda}{\int \pi_{k}(\lambda \mid y) \phi_{N}\left(\hat{\lambda} ; \lambda, \sigma^{2} / T\right) d \lambda} \\
& \quad=\sum_{k=1}^{K} \bar{\omega}_{k}(\hat{\lambda}, y) m\left(\hat{\lambda}, y ; \pi_{k}\right) .
\end{align*}
$$

Thus, the posterior mean is a weighted average of the posterior means derived from the $K$ mixture components. The $\bar{\omega}(\hat{\lambda}, y)$ can be interpreted as posterior probabilities of the mixture components. We can bound the posterior mean as follows:

\left|m\left(\hat{\lambda}, y ; \pi_{m i x}\right)\right| \leq \sum_{k=1}^{K}\left|m\left(\hat{\lambda}, y ; \pi_{k}\right)\right|=\sum_{k=1}^{K}\left|\bar{\gamma}_{0, k}+\bar{\gamma}_{1, k} y+\bar{\gamma}_{2, k} \hat{\lambda}\right| \leq M_{0}+M_{y}|y|+M_{\hat{\lambda}}|\hat{\lambda}| \tag{A.37}
\end{equation*}
$$

where the $\bar{\gamma}$ coefficients were defined in (A.33) and are bounded for $\pi_{k} \in \Pi$. Thus, that the overall bound for $\left|m\left(\hat{\lambda}, y ; \pi_{m i x}\right)\right|$ is piecewise linear in $y$ and $\hat{\lambda}$. The joint sampling distribution of $(\hat{\lambda}, y)$ is given by the following mixture of normals:

p\left(\hat{\lambda}, y ; \pi_{m i x}\right)=\int p(\hat{\lambda} \mid \lambda) \sum_{k=1}^{K} \omega_{k} \pi_{k}(\lambda, y) d \lambda=\sum_{k=1}^{K} \omega_{k} p\left(\hat{\lambda}, y ; \pi_{k}\right) . \tag{A.38}
\end{equation*}
$$

Based on (A.37) and (A.38) one can establish the uniform tailbounds in the assumption. Calculations under the $p_{*}(\cdot)$ distributions are very similar.

## A. 3 Derivations for Section 4

## A.3.1 Consistency of QMLE in Experiments 2 and 3

We show for the basic dynamic panel data model that even if the Gaussian correlated random effects distribution is misspecified, the pseudo-true value of the QMLE estimator of $\theta$
corresponds to the "true" $\theta_{0}$. We do so, by calculating

\left(\theta_{*}, \xi_{*}\right)=\operatorname{argmax}_{\theta, \xi} \mathbb{E}_{\theta_{0}}^{\mathcal{Y}}\left[\ln p\left(Y, X_{2} \mid H, \theta, \xi\right)\right], \tag{A.39}
\end{equation*}

and verifying that $\theta_{*}=\theta_{0}$. Because the observations are conditionally independent across $i$ and the likelihood function is symmetric with respect to $i$, we can drop the $i$ subscripts.

We make some adjustment to the notation. The covariance matrix $\Sigma$ only depends on $\gamma$, but not on $(\rho, \alpha)$. Moreover, we will split $\xi$ into the parameters that characterize the conditional mean of $\lambda$, denoted by $\Phi$, and $\omega$, which are the non-redundant elements of the prior covariance matrix $\underline{\Omega}$. Finally, we define

\tilde{Y}\left(\theta_{1}\right)=Y-X \rho-Z \alpha
$$

with the understanding that $\theta_{1}=(\rho, \alpha)$ and excludes $\gamma$. Moreover, let $\phi=\operatorname{vec}\left(\Phi^{\prime}\right)$ and $\tilde{h}^{\prime}=I \otimes h^{\prime}$, such that we can write $\Phi h=\tilde{h}^{\prime} \phi$. Using this notation, we can write

& \quad-\frac{1}{2} \ln |\underline{\Omega}|+\frac{1}{2} \ln |\bar{\Omega}(\gamma, \omega)| \\
& \\
& \quad-\frac{1}{2}\left(\hat{\lambda}(\theta)^{\prime} w^{\prime} \Sigma^{-1}(\gamma) w \hat{\lambda}(\theta)+\phi^{\prime} \tilde{h} \underline{\Omega}^{-1} \tilde{h}^{\prime} \phi-\bar{\lambda}^{\prime}(\theta, \xi) \bar{\Omega}^{-1}(\gamma, \omega) \bar{\lambda}(\theta, \xi)\right),
\end{align*}
$$

where

\begin{aligned}
\hat{\lambda}(\theta) & =\left(w^{\prime} \Sigma^{-1}(\gamma) w\right)^{-1} w^{\prime} \Sigma^{-1}(\gamma) \tilde{y}\left(\theta_{1}\right) \\
\bar{\Omega}^{-1}(\gamma, \omega) & =\underline{\Omega}^{-1}+w^{\prime} \Sigma^{-1}(\gamma) w, \quad \bar{\lambda}(\theta, \xi)=\bar{\Omega}(\gamma, \omega)\left(\underline{\Omega}^{-1} \tilde{h}^{\prime} \phi+w^{\prime} \Sigma^{-1}(\gamma) w \hat{\lambda}(\theta)\right) .
\end{aligned}

In the basic dynamic panel data model $\lambda$ is scalar, $w=\iota, \Sigma(\gamma)=\gamma^{2} I, x_{2}=\emptyset, z=\emptyset$, $h=\left[1, y_{0}\right]^{\prime}, \underline{\Omega}=\omega^{2}$. Thus, splitting the $(T-1)\left(\ln \gamma^{2}\right) / 2$, we can write

& -\frac{1}{2} \ln \left|\omega^{2}\right|-\frac{1}{2} \ln \left|\gamma^{2} / T\right|+\frac{1}{2} \ln (1 / T)+\frac{1}{2} \ln |\bar{\Omega}(\gamma, \omega)| \\
& -\frac{1}{2}\left(\frac{T}{\gamma^{2}} \hat{\lambda}^{2}(\rho)+\frac{1}{\omega^{2}} \phi^{\prime} \tilde{h} \tilde{h}^{\prime} \phi-\frac{1}{\bar{\Omega}(\gamma, \omega)} \bar{\lambda}^{2}(\theta, \xi)\right),
\end{aligned}
$$

where

\begin{aligned}
\hat{\lambda}(\rho) & =\frac{1}{T} \iota^{\prime} \tilde{y}(\rho) \\
\bar{\Omega}^{-1}(\gamma, \omega) & =\frac{1}{\omega^{2}}+\frac{1}{\gamma^{2} / T}, \quad \bar{\lambda}(\theta, \xi)=\bar{\Omega}(\gamma, \omega)\left(\frac{1}{\omega^{2}} \tilde{h}^{\prime} \phi+\frac{T}{\gamma^{2}} \hat{\lambda}(\rho)\right) .
\end{aligned}

Note that

## A.3.2 Computation of the Oracle Predictor in Experiment 3

We are using a Gibbs sampler to compute the oracle predictor under the mixture distributions for both $\lambda_{i}$ and $U_{i t}$.

Here we combine the scale mixture and the location mixture in a unified framework. Let $a_{i t}=1$ if $U_{i t}$ is generated from the mixture component with mean $\mu_{+}$and variance $\gamma_{+}^{2}$, and $a_{i t}=0$ if $U_{i t}$ is generated from the mixture component with mean $\mu_{-}$variance $\gamma_{-}^{2}$. Then, $\mu_{+}=\mu_{-}=0$ for the scale mixture, and $\gamma_{+}^{2}=\gamma_{-}^{2}=\gamma^{2}$ for the location mixture. Also, let $b_{i}$ be an indicator of the components in the correlated random effects distribution, such that

## A. 4 Proofs for Section 5.3

Lemma A. 9 Suppose that $T \geq k_{w}+1 \geq 2$. Suppose that $W$ is a $T \times k_{w}$ matrix with $\operatorname{rank}(\mathrm{W})=\mathrm{k}_{\mathrm{w}}$. Let $\Sigma$ be a $T \times T$ matrix of rank $T$. Let $S=\Sigma W$. Then, $\operatorname{rank}\left(\mathrm{M}_{\mathrm{S} \otimes \mathrm{S}} \mathrm{B}\right)=\mathrm{T}$, where $M_{S \otimes S}$ and $B$ are defined in the proof of Theorem 5.3.

Proof of Lemma A.9. Notice that the matrix $B$ is a $T^{2} \times T$ selection matrix that has one at positions $(1,1),(T+2,2),(2 T+3,3), \ldots,\left(T^{2}, T\right)$ and zeros at the other positions. Notice that since $\Sigma$ is full $\operatorname{rank}, \operatorname{rank}(S)=\operatorname{rank}(\Sigma W)=\operatorname{rank}(W)=k_{w}$. If $\operatorname{rank}(S)=k_{w}$, then $\operatorname{rank}(S \otimes S)=k_{w}^{2}$. Since the rank of the projection matrix is the same as its trace, we have $\operatorname{rank}\left(M_{S \otimes S}\right)=\operatorname{tr}\left(M_{S \otimes S}\right)=T^{2}-k_{w}^{2}$.

Notice that $\Lambda F^{\prime} B$ is a submatrix of $F^{\prime} B$ that selects the first $T^{2}-k_{w}^{2}$ rows. Since $T-1 \geq k_{w}$ and $T \geq 2$ implies that $T^{2}-k_{w}^{2} \geq 2 T-1>T$, the $\left(T^{2}-k_{w}^{2}\right) \times T$ submatrix of $F^{\prime} B, \Lambda F^{\prime} B$, has rank $T$.

## B Data Set

The construction of our data is based on Covas, Rump, and Zakrajsek (2014). We downloaded FR Y-9C BHC financial statements for the quarters 2002Q1 to 2014Q4 using the web portal of the Federal Reserve Bank of Chicago. We define PPNR (relative to assets) as follows

Here net interest income is the difference between total interest income and expenses. It excludes provisions for loan and lease losses. Non-interest income includes various types of fees, trading revenue, as well as net gains on asset sales. Non-interest expenses include, for instance, salaries and employee benefits and expenses of premises and fixed assets. As in Covas, Rump, and Zakrajsek (2014), we exclude impairment losses (C216 and C232). We divide the net revenues by the amount of consolidated assets. This ratio is multiplied by 400 to annualize the flow variables and convert the ratio into percentages.

The raw data take the form of an unbalanced panel of BHCs. The appearance and disappearance of specific institutions in the data set is affected by entry and exit, mergers and acquisitions, as well as changes in reporting requirements for the FR Y-9C form. Note that NII, ONII, and ONIE are reported as year-to-date values. Thus, in order to obtain quarterly data, we take differences: $Q 1 \mapsto Q 1,(Q 2-Q 1) \mapsto Q 2,(Q 3-Q 2) \mapsto Q 3$, and $(Q 4-Q 3) \mapsto Q 4$. ASSETS is a stock variable and no further transformation is needed.

Our goal is to construct rolling samples that consist of $T+2$ observations, where $T$ is the size of the estimation sample and varies between $T=3$ and $T=11$. The additional two observations in each rolling sample are used, respectively, to initialize the lag in the first period of the estimation sample and to compute the error of the one-step-ahead forecast. We index each rolling sample by the forecast origin $t=\tau$. For instance, taking the time period $t$ to be a quarter, with data from 2002Q1 to 2014Q4 we can construct $M=45$ samples of size $T=6$ with forecast origins running from $\tau=2003 Q 3$ to $\tau=2014 Q 3$. Each rolling sample is
indexed by the pair $(\tau, T)$. The following adjustment procedure that eliminates BHCs with missing observations and outliers is applied to each rolling sample $(\tau, T)$ separately:

1. Eliminate BCHs for which total assets are missing for all time periods in the sample.
2. Compute average non-missing total assets and eliminate BCHs with average assets below 500 million dollars.
3. Eliminate BCHs for which one or more PPNR components are missing for at least one period of the sample.
4. Eliminate BCHs for which the absolute difference between the temporal mean and the temporal median exceeds 10 .
5. Define deviations from temporal means as $\delta_{i t}=y_{i t}-\bar{y}_{i}$. Pooling the $\delta_{i t}$ 's across institutions and time periods, compute the median $q_{0.5}$ and the 0.025 and 0.975 quantiles, $q_{0.025}$ and $q_{0.975}$. We delete institutions for which at least one $\delta_{i t}$ falls outside of the range $q_{0.5} \pm\left(q_{0.975}-q_{0.025}\right)$.

The effect of the sample-adjustment procedure on the size of the rolling samples is summarized in Table A-1. Here we are focusing on samples with $T=6$ as in the main text. The column labeled $N_{0}$ provides the number of raw data for each sample. In columns $N_{j}$, $j=1, \ldots, 4$, we report the observations remaining after adjustment $j$. Finally, $N$ is the number of observations after the fifth adjustment. This is the relevant sample size for the subsequent empirical analysis. For many BCHs we do not have information on the consolidated assets, which leads to reduction of the sample size by $60 \%$ to $80 \%$. Once we restrict average consolidated assets to be above 500 million dollars, the sample size shrinks to approximately 700 to 1,200 institutions. Roughly $10 \%$ to $25 \%$ of these institutions have missing observations for PPNR components, which leads to $N_{3}$. The outlier elimination in Steps 4. and 5 . have a relatively small effect on the sample size.

Descriptive statistics for the $T=6$ rolling samples are reported in Table A-2. For each rolling sample we pool observations across institutions and time periods. We do not weight the observations by the size of the institution. Notice that the mean PPNR falls from about $2 \%$ for the 2003 samples to $1.24 \%$ for the 2010Q2 sample, which includes observations starting in 2008Q4. Then, the mean slightly increases and levels off at around $1.3 \%$. The means are close to the medians, suggesting that the samples are not very skewed, which is
confirmed by the skewness measures reported in the second to last column. The samples also exhibit fat tails. The kurtosis statistics range from 4 to 190 .
